

**District 13 Minutes**  
**May 26, 2016**

When someone signs up on our website this will be a non-refundable commitment on their part. They will be billed for the amount of the class.

Corrina will help with the food. She will contact Sam from North Powder and put something together.

David Blair is checking into the Randy Carpenter grant for grants or scholarships for the departments. Since Dist. 13 is the hosting district we might be able to get help with costs. Signups will go to District 13 c/o David Blair 1616 2<sup>nd</sup> St. Baker City, Oregon 97814. Chris will get the final draft to sign up out as soon as possible.
